Comes now Relator *ex rel.* the fifty (50) State and Commonwealth Plaintiffs, with the following returns of service upon all named Defendants and the Cross-Defendant, to-wit:

All ten (10) formally named non-governmental Defendants and also Cross-Defendant United States have each acknowledged receipts of certified mailings for the initial, full Verified Complaint package served on November 6th, 2012 (see Exhibit “A” attached).

While Relator is unaware of any Rule requiring service upon his own fellow Plaintiffs, courtesy and common sense copy of the same initial, full Verified Complaint package was also served upon the National Governors’ Association, the National Association of Attorneys General, and the National Conference of State Legislatures (see Exhibit “B”).

All ten (10) formally named non-governmental Defendants and also Cross-Defendant United States again acknowledged this case by separate certified mailings for their own Summonses (see Exhibit “C” attached). Cross-Defendant United States was again served

both the full Verified Complaint package and also copies of Summonses upon the White House and the U.S. Attorney General, in a subsequent service (see Exhibit “D” attached).
